I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Council Assessor's Report (May, 2015) on the physical and other teaching facilities available at Alluri Sitarama Raju Academy of Medical Sciences, Eluru for Renewal of recognition of MD/MS(OBG) & DGO qualification for 2 seats each and recognition of MD/MS(OBG) qualification against increased intake from 04 to 08 seats under Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh and the Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD/MS(OBG) qualification against increased intake from 04 to 08 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Silarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee further decided to recommend to the Central Government that recognition of MD/MS(OBG) & DGO qualifications for 02 seats each granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.
