Sub: Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MS(Orthopaedics) qualification against increased intake from 03 to 06 and renewal of recognition of D.Ortho. qualification for 3 seats in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru.

Sir/ Madam,

I am to state that the General Body of this council at its meeting held on 01/10/2015 considered the Compliance Verification Assessment Report (27/03/2015) along with the Council Assessor's report (March, 2014 and May, 2014) on the standard of examination and other teaching facilities available at Alluri Sitarama Raju Academy of Medical Sciences, Eluru for purpose of Recognition of MS(Orthopaedics) qualification against increased intake from 03 to 06 and renewal of recognition of D.Ortho. qualification for 3 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/03/2015) along with the Council Assessor's Report (March, 2014 and May, 2014) and decided to recommend to the Central Government that MS(Orthopaedics) qualification against increased intake from 03 to 06 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that recognition of D.Ortho. qualification for 3 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
