I am to state that the General Body of this council at its meeting held on 01/10/2015 considered the Council Assessor's report (May, 2015) on the standard of examination and other teaching facilities available at Alluri Sitarama Raju Academy of Medical Sciences, Eluru for purpose of Recognition of MD(Radio Diagnosis) qualification against increased intake from 04 to 05 seats and renewal of recognition of MD(Radio Diagnosis) for 1 seat & DMRD qualification against increased intake from 1 to 2 seat granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Radio Diagnosis) qualification against increased intake from 04 to 05 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that recognition of MD(Radio Diagnosis) qualification for 1 seat & DMRD qualification against increased intake from 1 to 2 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.".
